Venta Cleaner

is a mild, environmentally friendly detergent developed in conjunction with Venta Hygiene Additive to ensure the long-term, optimally hygienic operation of the high-quality equipment made by Venta Luftwäscher GmbH.

Under normal operation of the Venta Airwasher, the salt and lime deposits from the tap water supply and the collected impurities from the air are removed by simple rinsing with water, provided the **Venta Hygiene Additive** has been added.

Due to the machine's construction, certain parts are not fully accessible, such as the axes of the rotating disk stack. In order to clean these areas, it is recommended that a general cleaning of the Airwasher be undertaken at least every six months to remove all debris and to ensure the smooth operation of your Venta Airwasher.

The Venta Cleaner naturally removes stubborn dirt and lime with a highly effective lemon descaler. It contains no aggressive, highly corrosive additives in order to avoid damaging the high-quality materials. Efficient and thorough cleaning is assured in spite of the high dilution of 1:40 (250 ml to 10 liters of water). The Cleaner is odourless and colourless, non-corrosive and very biodegradable.

Application:

After rinsing off the loose deposits, fill the device with tap water so that it covers the rotating disk stack axis and add a full bottle of Cleaner. Then run the machine for about 2 hours at level 1. The process can be accelerated with slightly warmed water. Then drain the dirty water and rinse well with cold water. The Venta Airwasher can be then be refilled as before with water and Venta-Hygiene Additive.

Note:

- Please ensure good ventilation during cleaning to avoid any possible smells that can occur when the device is very dirty.
- Do not use any other acidic cleaners or other descaling agents, as these often contain harmful additives (solvents, surfactants, formic acid, etc.), which can cause stress corrosion cracking of plastic parts.

Shelf Life

The Venta Cleaner should be kept in a cool, dark storage space and protected from sunlight. The storage temperature should be between 5° C and 30 °C. It is recommended that the Cleaner is used within 2 years.

Environmental aspects / Regulations

The **Venta Cleaner** does not require a label under the Hazardous Substances Regulation. The Cleaner is regulated under the Detergents Regulation (EC) No 648/2004 and its amendments. The surfactants contained in this preparation comply with the biodegradability criteria as laid down and defined in the above regulation. Documentation to support this assertion is readily available to the respective authorities of the Member States. The product contains the following ingredients:

- <20% citric acid / malic acid, <5% amphoteric tensides preservatives (BIT/MIT)
- Water hazard classification (WGK): 1 (unused product)
